Dear Chairman Brewer:

Thank you for the opportunity to meet with you in February to discuss my budget priorities, as well as your willingness to engage in further conversation as the budget deliberations continue. In February, we discussed the following top budget priorities:

- 1) A significant investment in transportation;
- 2) An equitable Chapter 70 funding formula;
- 3) Full funding of the special education circuit breaker;
- 4) A grant program for differentiated/digital learning:
- 5) The Department of Public Health;
- 6) The Department of Conservation and Recreation; and
- 7) Expanded eligibility for emergency shelter.

These items remain my top priorities. However, I would like to take this opportunity to identify some additional budget items that are of importance to me and my constituents and have more recently been communicated to me.
