Dear Chairman Brewer:

I appreciate the opportunity to meet with you to discuss my budget priorities for the FY15 budget. I would like to highlight the following priorities as my top priorities:

- Complete the overdue effort reduction and downpayment aid schedules in the Chapter 70 funding formula, for an increase of \$50.6 million;
- Fund the Special Education Circuit Breaker account fully, with an allowance for inflation;
- 3) Fund the Department of Conservation and Recreation fully;
- 4) Increase funding for the Massachusetts Legal Assistance Corporation; and
- 5) Expand and increase access to quality early education, and improve quality for early educators.

In addition to these top priorities, I wish to highlight the line-items below, which are of particular importance to me and my constituents. I will provide you with a supplemental list of priorities closer to the time the Senate deliberates the budget, once I have heard from more constituents.
