Affordability

The Massachusetts State Senate prioritized several practical initiatives this session as part of our **Affordability Agenda** to make life more affordable for residents.

Consumer Savings



We focused on ways to help residents save money and avoid costly pitfalls. We make live music more affordable by capping ticket resale prices. Consumers get added protection through new debt collection reforms, and we protect residents from scams by banning cryptocurrency ATMs. We also give shoppers a break through our annual sales tax holiday.

Education



We make higher education more affordable by fully funding tuition-free community college and creating a new student support fund to help with financial aid and stipends, ensuring more students can earn degrees without financial barriers. We have also guaranteed free breakfast and lunch for all K–12 students, allowing caregivers to keep more money in their pockets.

Energy



We are tackling high energy costs with a major legislative package designed to eliminate hidden fees, curb price spikes, and boost transparency—promising billions in long-term savings for households, while maintaining our commitment to our climate goals.

Healthcare



Our *Primary Care and You* bill cuts costs by shifting our healthcare system toward prevention. Investing in primary care providers means they can stay open and hire more staff, thereby reducing wait times, reducing ER visits and expensive specialty procedures. We also expand *ConnectorCare*, which helps residents access more affordable insurance with lower premiums, no deductibles, and reduced co-pays.

Housing



We expand options for affordable homeownership, provide several ways to tackle property tax relief, and ensure broker fees are not paid by renters. We also streamline the conversion of commercial space into residential units and allow two-family homes on any residential lot—helping more people find homes that fit their budgets.

Public Transportation



We are making public transportation more affordable and accessible. Residents with lower incomes now have expanded access to lower-cost options on the MBTA, and we made fare-free regional transit permanent, allowing all riders to use Regional Transit Authorities at no cost.

AN ACT AUTHORIZING THE DIVISION OF CAPITAL ASSET MANAGEMENT AND MAINTENANCE TO TAKE BY EMINENT DOMAIN CERTAIN LAND IN THE TOWN OF NORWOOD

Clears the way for the revitalization of Norwood Hospital, addressing the increased emergency transportation costs that have fallen on local communities and residents as a result of the hospital's multi-year closure.

- Modernizes the variance standard.

Extends the *ConnectorCare* expansion pilot program through 2027. Since 2024, over 115,000 individuals have gained more affordable insurance, lower premiums, no deductibles, and reduced co-pays, further helping residents access preventive services and medications for chronic conditions.

Scammers in recent years have directed older adults to use crypto kiosks to send money which is often not recoverable when the fraud is discovered, leading some seniors to lose their entire life savings.

AN ACT RELATIVE TO VETERAN PROPERTY TAX WORK-OFF

Bolsters the targeted tax relief offered to veterans and spouses of deceased or disabled veterans by allowing them to reduce their property taxes by up to \$2,000 per year in exchange for providing volunteer services to their municipality, an increase from the current \$1,500 cap, under a provision local governments can choose to adopt.

AN ACT AUTHORIZING THE ESTABLISHMENT OF A MEAN TESTED SENIOR CITIZEN PROPERTY TAX EXEMPTION

Creates a statewide property tax exemption program for eligible seniors in participating communities. Municipalities would be able to opt in or out of the senior citizen property tax exemption by a vote of their town meeting, city council, or other local legislative body. Makes relief available, in participating communities, to seniors who are age 65 or older, own and occupy the eligible property, have lived there for at least the last ten years, and meet certain financial requirements. Allows municipality to set the annual amount for their local senior tax exemption, which would be spread proportionally across the town or city's residential tax levy.

AN ACT TO PREVENT PROPERTY TAX BILL SHOCKS

Gives cities and towns the ability to shield taxpayers aged 65 and older who own and occupy their home, enrolled in MassHealth, or living with children under age six from the shock of an extraordinarily high tax bill in a year when the community's residential property tax levy rises by more than 10 per cent. Gives cities and towns the further option of expanding eligibility to cover people with children under the age of 18.

AN ACT RELATIVE TO MUNICIPAL TAX RELIEF

Allows cities and towns to determine their residents' eligibility and set their own thresholds around assets, income, or other factors. Boosts the existing senior property tax exemption by giving municipalities the option of further expanding eligibility and raising the limit of possible exemption from \$500 to \$1,500.

AN ACT RELATIVE TO SENIOR PROPERTY TAX DEFERRAL

Gives more time to heirs to plan for and pay the deferred taxes by delaying an increase in the interest rate for deferred taxes until a year after the taxpayer's death and delaying the date on which a foreclosure petition may be filed until 18 months after their death. Prioritizes current military servicemembers by ensuring that these interest rate and lien changes are mirrored in an existing property tax deferral for active members of the military.

Across Massachusetts, residents are struggling with rising housing costs—and many, especially young people, worry about whether they can build a future here. In response, the Massachusetts Senate has ***made housing a central focus of its legislative agenda***, embedding ***key policies and funding across major bills and budgets***.

Building More Housing

We prioritized policies that make it faster, more predictable, and more financially feasible to build new housing. Major permitting reforms stabilize zoning rules from the moment a building permit application is filed through the completion of construction, preventing projects from being derailed by midstream regulatory changes. We also strengthened environmental permitting efficiency, expediting wetlands reviews while maintaining strong safeguards.

Our Economic Development Bond Bill expands housing production tools even more, requiring automatic two-family zoning and enabling easier commercial-to-residential conversions, among other things.

Finally, cutting the sales tax on certain building materials lowers construction costs in the face of tariffs, helping more projects move forward. Over time, that means more apartments and homes being built.

Keeping Housing Affordable

We also worked to create far more housing that people can actually afford. A package of tax-relief tools gives cities and towns the ability to reduce property tax costs and put savings directly into residents' pockets.

By doubling and tripling key housing funds, the state can build more affordable homes and renovate older ones, increasing the number of places where residents can live without being priced out. By investing billions to modernize and upgrade public housing, the Senate is making sure that tens of thousands of older residents, families, and people with disabilities can continue living in safe, healthy homes.

Fighting for Renters

We advanced several measures that support renters and strengthen the multifamily housing market. We created construction sales tax relief for multifamily developments serving low-, moderate-, and middle-income residents—lowering costs for projects that produce rental homes.

We also got rid of unfair broker fees, saving thousands of dollars for renters hoping to find that new apartment.

FISCAL YEAR 2027 BUDGET POLICY PROVISIONS ON STREAMLINED LOCAL HOUSING PERMITTING

Includes numerous provisions to streamline local housing permitting, intended to boost new housing production in Massachusetts. These updates reflect the Senate’s ongoing commitment to making Massachusetts more affordable for families and young adults, as well as progress following the Legislature’s passage of the Affordable Homes Act in 2024:

- Makes it easier for homeowners and developers to work with buildings or properties that do not fully meet current zoning rules because they were built under older codes;
- Requires local permitting authorities to account for the ‘public interest’ in housing production as a factor when considering whether to grant a variance;
- Locks zoning rules in place at the time a building permit application is filed and vests them throughout the building process so that projects are not jeopardized by changing rules midway through the project;
- Provides reasonable timelines for projects to proceed under existing zoning rules; and
- Modernizes the variance standard.

FISCAL YEAR 2026 CONSOLIDATED SUPPLEMENTAL BUDGET PROVISION ON HOUSING CONSTRUCTION

Creates a new sales tax exemption to foster multifamily housing production and combat the negative impact of tariffs and inflation on housing development in Massachusetts. Applies to the sales of building materials used in the construction of approved affordable, moderate income, and middle-income housing projects, capped at \$35 million per year. Follows the Senate’s action through the Fiscal Year 2026 budget to study the removal of the sales tax for certain housing supply items.

Gives cities and towns the further option of expanding eligibility to cover people with children under the age of 18.

Makes relief available, in participating communities, to seniors who are age 65 or older, own and occupy the eligible property, have lived there for at least the last ten years, and meet certain financial requirements. Allows municipality to set the annual amount for their local senior tax exemption, which would be spread proportionally across the town or city's residential tax levy.

The Massachusetts Senate has undertaken a wide-ranging set of reforms aimed at ***strengthening transparency, accountability, and efficiency across state government***, reflecting a commitment to ensuring residents have clearer insight into public decision-making and fiscal stewardship.

Expanding Public Records Access

Under our bill, the Senate, House and Governor would be explicitly required to comply with public records requests for the first time. We mandate disclosure of legislative records including voting histories, salary information, ethics filings, operating expenditures, and specific categories of contracts. We also create an independent appeals process to help members of the public resolve disputes over access.



Strengthening Transparency Through Updated Senate Rules

In our Senate rules, we require the publication of all committee votes taken by Senators in joint and Senate-only committees. We also mandate that written and in-person testimony submitted to committees be made publicly available online; direct committees to publish plain-language bill summaries online; and require cybersecurity training for all Senators and staff in addition to ethics, harassment, and implicit bias training mandates.

Reforming Joint Rules for Efficiency and Accessibility

The Legislature adopted comprehensive joint rules this session that modernize and streamline lawmaking. We require committees to post plain language bill summaries online, provide earlier public notice of hearings, and publish committee attendance and voting records. These reforms empower committees to take independent action on bills originating from their respective chambers while allowing formal lawmaking to continue throughout the full two-year session—providing greater flexibility and more time for thoughtful policymaking.

Balancing Constitutional Safeguards with Legislative Accountability

In response to a Supreme Judicial Court order, we adopted a resolution to provide documents related to our financial operations in four requested areas to the Office of the State Auditor. We also created a new public web page to provide real-time financial data to the public.

Promoting Long-Term Stability and Fiscal Oversight

We continued to make significant fiscal decisions aimed at improving long-term efficiency and stability. The final Fiscal Year 2027 budget dedicates an additional \$51 million to the Commonwealth's Stabilization Fund, raising its balance to a historic \$8.2 billion. We also took steps to strengthen fiscal oversight of some aspects of state government to ensure responsible stewardship of public resources while enhancing transparency. And we did it all without raising taxes or fees.
